

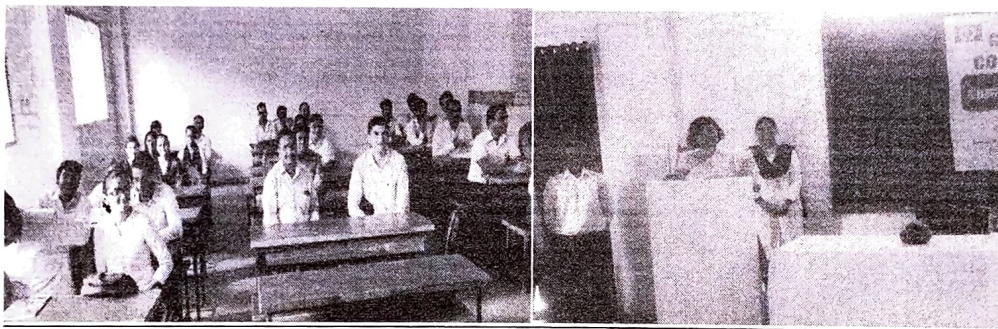

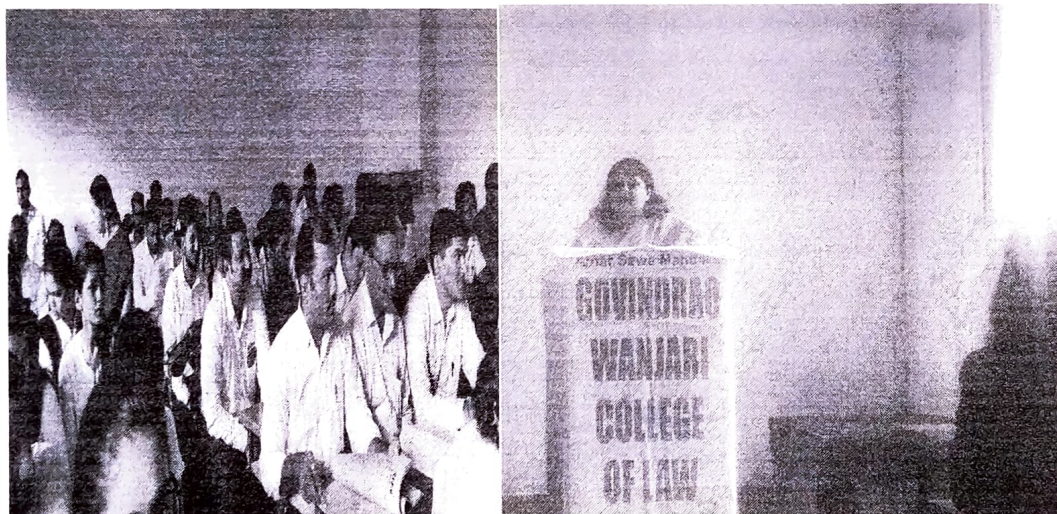

The primary reason behind securing trademarks for buildings is to protect copycat architecture and protect the unique design of the building and preserve its uniqueness and heritage. Buildings satisfy the dual test of graphical representation, along with the capability of functioning as an indication of source and are hence eligible for trademark protection. A Lecture by Expert on Patent Issue was conducted on college Auditorium on 24/01/ 2020, at 11am. The Key note Speaker was Dr. Ushosi Guha. Expertise in Intellectual Property Law and Prosecution, Lex Regia, Patent Attorney in Nagpur. She Highlighted on Patentable Subjects Matters in India.



She explained that patentability of an invention is subject to satisfaction of all patentability requirements provided under the Patents Act. Five patentability requirements may be crystallised from the provisions of the Act. They are provided in different provisions ranging from definition of invention to constituents of specification. Each requirement checks the worthiness of an invention for patent grant from a different perspective. The requirements are not water tight compartments, and analysis of one requirement sometimes merges with that of another.

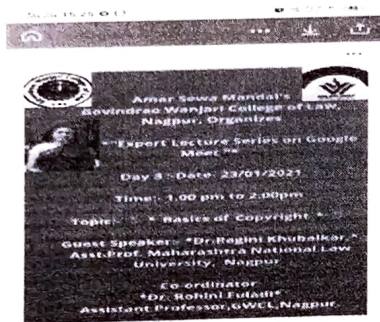
