STUDENTS GRIEVANCE REDRESSAL CELL

Introduction:

As per UGC Regulations, Late Govindrao Wanjari College of Law has established the Students Grievance Redressal Cell (SGRC) which aims to look into the grievances of students and redress it as per requirement. The students can state their grievances regarding any academic and non-academic matter within the campus in written, online or through grievance/ suggestion box. The college aims at solving the grievances of the students within the campus in stipulated time.

Objectives:

The students Grievance Redressal Cell has been established to settle the grievances of the students within a reasonable time period for further strengthening the bond of the students with the college by providing them with all kind of facilities to a satisfaction level for maintaining a convenient environment of academic teaching and learning.

Mechanism of the SGRC-

The Students Grievance Redressal Cell (SGRC) shall consider individual and collective grievances of specific nature of students.

- 1. Post receipt of the complaint/application the committee will decide on the merit of case regarding scope of further discussion investigation and act promptly.
- 2. SGRC will meet twice in a session and as and when required.
- 3. SGRC shall consider redressing of grievances within a reasonable time.

Scope:

The students may lodge grievance about any academic and non- academic matters in the college.

Procedure for lodging complaint:

- 1. The students can lodge their grievance by filing a complaint in person (oral/in writing) to the college or by mail or simply by dropping in a suggestion box.
- 2. The SGRC will act upon those complaints which have been forwarded along with the required documents.
- 3. The SGRC will assure that the grievance has been accordingly resolved in a stipulated time limit provided by the cell.
